Richard Bernstein Advisors Has Trimmed Its Stake in Norfolk Southern (NSC) as Share Price Rose; Ashmore Group Plc Holding in Ecopetrol Sa (EC) Lowered by \$1.58 Million

Richard Bernstein Advisors Lic decreased its stake in Norfolk Southern Corp (NSC) by 31.72% based on its latest 201804 regulatory filing with the SEC. Richard Bernstein Advisors Lic sold 9,077 shares as the company's stock rose 7.11% with the market. The institutional investor held 19,538 shares of the railroads company at the end of 201804, valued at \$2.92 million, down from 28,615 at the end of the previous reported quarter. Richard Bernstein Advisors Lic who had been investing in Norfolk Southern Corp for a number of months, seems to be less bullish one the \$52.01 billion market cap company. The stock increased 0.20% or \$0.39 during the last trading session,


