Ecopetrol Sa Spon Adr 1 Rep 20 (EC) Shareholder Ubs Global Asset Management Americas Boosted Its Stake by \$939.03 Million as Share Price Declined; Newtyn Management Boosted Position in Pg&E (PCG) by \$52.24 Million as Valuation Rose

Ubs Global Asset Management Americas Inc increased its stake in Ecopetrol Sa Spon Adr 1 Rep 20 (EC) by 20.84% based on its latest 2019Q1 regulatory filing with the SEC. The institutional investor held 253,81 shares of the oil & gas production company at the end of 2019Q1, valued at \$5.45 billion, up from 210,181 at the end of the previous reported quarter. 
