Ashmore Group Plc Holding in Ecopetrol Sa (EC) Has Decreased as Shares Rose; Jpmorgan Chase & Co (JPM) Shareholder Round Table Services Lowered Its Holding by \$323,495

Ashmore Group Pic decreased its stake in Ecopetrol Sa (EC) by 45.65% based on its latest 2018Q4 regulatory filling with the SEC. Ashmore Group Pic sold 105,000 shares as the company's stock rose 9.48% with the market. The institutional investor held 125,000 shares of the oil 8 gas production company at the end of 2018Q4, valued at \$1.99M, down from 230,000 at the end of the previous reported quarter. Ashmore Group Pic who had been investing in Ecopetrol Sa for a number of months, seems to be less bullish one the \$734.76 billion market cap company. The stock increased

2.35% or \$0.41 during the last trading session, reaching \$17.87. About 443,885 shares traded. Ecopetrol S.A. (NYSE:EC) has risen 20.53% since May 25, 2018 and is uptrending. 

JPM's profit will be \$8.30 billion for 10.71 P/E if the \$2.56 EPS becomes a reality. After \$2.65 actual earnings per share reported by JPMorgan Chase & Co. for the previous quarter, Wall Street now forecasts -3.40% negative EPS growth.
