# **Ecopetrol** (NYSE:EC) Upgraded by Zacks Investment Research to "Hold"

Zacks Investment Research upgraded shares of Ecopetrol (NYSE:EC) from a strong sell rating to a hold rating in a research note released on Monday morning, Zacks.com reports.

According to Zacks, "ECOPETROL S.A. is a Colombiabased petroleum company. The Company is

focused on identifying opportunities primarily within the eastern Llanos Basin of Colombia, as well as in other areas in Colombia and northern Peru. The Company's operation includes the extraction, collection, treatment, storage and pumping or compression of hydrocarbons. Ecopetrol has four management divisions to handle the operation of 163 production fields. Ecopetrol's production is concentrated in the upper, middle and lower Magdalena, the Eastern Plans and the Caribbean, and the provinces of Putumayo, Cesar and Norte de Santander. "

EC has been the subject of a number of other reports. The Goldman Sachs Group cut shares of Ecopetrol from a buy rating to a neutral rating and set a \$14.70 price target for the company. in a report on Wednesday, December 15th. TheStreet cut shares of Ecopetrol from a b-rating to a crating in a report on Wednesday, December 15th. Finally, JPMorgan Chase & Co. cut shares of Ecopetrol from a neutral rating to an underweight rating and set a \$16.50 price objective for the company. in a report on Monday, November 29th. One research analyst has rated the stock with a sell rating, two have assigned a hold rating and two have assigned a buy rating to the company's stock. According to data from MarketBeat.com, the company has a consensus rating of Hold and an average price target of \$15.40.

Shares of NYSE EC opened at \$14.14 on Monday. Ecopetrol has a twelve month low of \$11.37 and a twelve month high of \$15.91. The firm has a fifty day simple moving average of \$13.55 and a 200 day simple moving average of \$13.89. The company has a market capitalization of \$29.07 billion, a PE ratio of 9.62, a P/E/G ratio of 0.15 and a beta of 1.79. The company has a quick ratio of 1.36, a current ratio of 1.69 and a debtto-equity ratio of 0.89.

Ecopetrol (NYSE:EC) last announced its earnings results on Tuesday, November 9th. The oil and gas company reported \$0.48 earnings per share for the quarter, missing analysts' consensus estimates of \$0.59 by (\$0.11). Ecopetrol had a return on equity of 8.55% and a net margin of 15.03%. The firm had revenue of \$6.07 billion for the quarter, compared to the consensus estimate of \$6.06 billion. As a group, equities analysts expect that Ecopetrol will post 2.07 earnings per share for the current fiscal
