Clarivate Plc (NYSE:CLVT) traded with an addition of \$0.16 to \$14.49 on Thursday, an upside of 1.12 percent. An average of 4,419,384 shares of common stock have been traded in the last five days. There was a gain of \$1.01 in the past week, and it reached a new high 8 times over the past 12 months. The last 20 days have seen an average of 4,781,066 shares traded, while the 50-day average volume stands at 4,658,305.

CLVT stock has decreased by -16.05% in the last month. The company shares reached their 1-month lowest point of \$12.99 on 05/12/22. With the stock rallying to its 52-week high on 01/03/22, shares of the company touched a low of \$11.71 and a high of \$34.79 in 52 weeks. It has reached a new high 1 time so far this year and lost -39.07% or -\$9.09 in price. In spite of this, the price is down -58.35% from the 52-week high.

#### Insider Transactions

3 days have passed since Clarivate Plc (CLVT) last reported insider trading activity. Samson James Gordon, who is Chief Product Officer, most recently acquired \$50,000 shares at \$14.25 per share on May 16. In this transaction, the insider spent \$712,470. Chief Product Officer, Samson James Gordon, disposed of 58,000 shares at a price of \$13.91 on May 11. The insider now owns more than \$806,927 worth of shares. Prior to that, Chief Product Officer Samson James Gordon went on to Sale 16.000 shares at \$14.13 each on Mar 14. An amount of \$226,080 was transacted.

### Valuation Metrics

Clarivate Plc (CLVT) stock's beta is 0.90. Other valuation ratios to consider include the trailing price-to-sales (P/\$) ratio at 4.27, the price-to-book (PB) ratio at 0.95, and the price-to-cash flow ratio at 100.03.

## Financial Health

The quick ratio of Clarivate Plc for the three months ended March 30 was 0.90, and the current ratio was 0.90, indicating that the company is not able to meet its debt obligations. Further, the company has a long term debt to equity ratio of 0.53 and a total debt to equity ratio of 0.53 for the quarter ending March 30. Its gross profit as reported stood at \$1.25 billion compared to revenue of \$1.88 billion.

## Earnings Surprise

For the three-month period that ended March 30, Clarivate Plc had \$5.45 billion in total debt. In the quarter under review, the net income was up than the previous quarter. The company posted a net income of \$50.8 million in the quarter, while revenues were grew 147.15%. The analyst consensus anticipated Clarivate Plc's latest quarter earnings to come in at \$0.18 per share, but it turned out to be \$0.21, a 16.70% surprise. For the quarter, EBITDA amounted to \$221.3 million. Shareholders own equity worth \$672.55 million.

## Technical Picture

From a technical analysis perspective, let's take a brief look at Clarivate Plc (CLVT) price momentum. RSI 9-day as of the close on 18 May was 44.61%, suggesting the stock is Neutral, with historical volatility in this time frame at 47.75%.

As of today, CLVT's price is \$14.41 +7.53% or \$1.01 from its 5-day moving average. CLVT is currently trading -11.58% lower than its 20-day SMA and -41.29% lower than its 100-day SMA. However, the stock's current price level is +11.09% above the SMA50 and -39.57% below the SMA200.

The stochastic %K and %D were 48.65% and 46.19%, respectively, and the average true range (ATR) was 0.72. With the 14-day stochastic at 51.16% and the average true range at 0.74, the RSI (14) stands at 43.69%. The stock has reached 0.27 on the 9-day MACD Oscillator while the 14-day reading was at -0.07.

## **Analyst Ratings**

Citigroup downgraded Clarivate Plc (NYSE: CLVT) to a a Neutral rating in its most recent analyst report. Previously, the stock was rated as a Buy. The consensus rating for Clarivate Plc (CLVT) among analysts is Overweight. According to current brokerage recommendations, 0 brokerage firms advise that investors sell CLVT, while 2 suggest investors hold. There are 0 analysts who rate the stock as underweight. The stock is rated overweight by 0 analysts, while 6 others rate it as a "buy".

# What is CLVT's price target for the next 12 months?

Analysts predict a range of price targets between \$16.00 and \$23.00, with a median target of \$18.00. Taking a look at these predictions, the average price target given by analysts for Clarivate PIc (CLVT) stock is \$18.43.
