



11,939 Shares in Ecopetrol S.A. (NYSE:EC) Purchased by Cerity Partners LLC

Cerity Partners LLC purchased a new stake in Ecopetrol S.A. (NYSE:EC – [Get Rating](#)) in the second quarter, [HoldingsChannel.com](#) reports. The institutional investor purchased 11,939 shares of the oil and gas company's stock, valued at approximately \$130,000.

Other institutional investors have also recently made changes to their positions in the company. Penserra Capital Management LLC bought a new position in shares of Ecopetrol in the first quarter valued at \$47,000. DekaBank Deutsche Girozentrale bought a new position in shares of Ecopetrol in the 2nd quarter valued at about \$144,000. D.A. Davidson & CO. acquired a new position in shares of Ecopetrol during the 2nd quarter worth about \$147,000. Atlas Capital Advisors LLC lifted its stake in Ecopetrol by 87.0% in the 1st quarter. Atlas Capital Advisors LLC now owns 8,877 shares of the oil and gas company's stock valued at \$165,000 after purchasing an additional 4,129 shares during the last quarter. Finally, Farmer Steven Patrick acquired a new stake in Ecopetrol in the 2nd quarter valued at about \$174,000. Institutional investors and hedge funds own 1.44% of the company's stock.

Separately, [StockNews.com](#) assumed coverage on Ecopetrol in a research note on Wednesday, October 12th. They issued a "hold" rating on the stock. One analyst has rated the stock with a sell rating and three have assigned a hold rating to the company's stock. Based on data from MarketBeat, the company has a consensus rating of "Hold" and an average price target of \$15.60.

Ecopetrol Stock Performance

EC stock opened at \$10.25 on Thursday. Ecopetrol S.A. has a one year low of \$8.59 and a one year high of \$19.81. The stock has a market cap of \$21.07 billion, a price-to-earnings ratio of 6.97, a price-to-earnings-growth ratio of 0.05 and a beta of 1.56. The company has a fifty day moving average price of \$9.79 and a two-hundred day moving average price of \$11.35. The company has a debt-to-equity ratio of 0.79, a current ratio of 1.32 and a quick ratio of 1.11.

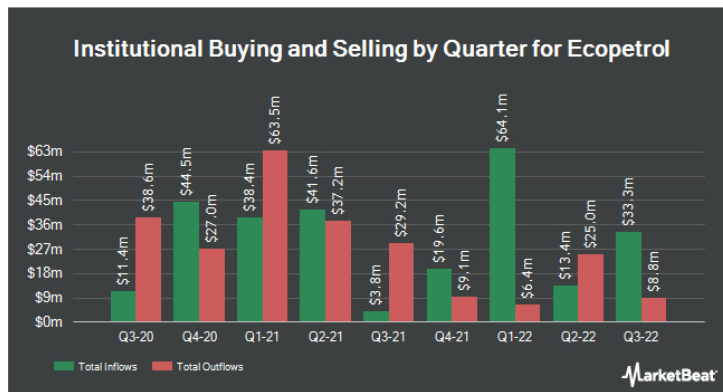
