Ritholtz Wealth Management Cuts Stock Position in Ecopetrol S.A. (NYSE:EC)

Ritholtz Wealth Management decreased its position in shares of Ecopetrol S.A. (NYSE:EC - Get Rating) by 24.0% in the second quarter, according to the company in its most recent Form 13F filing with the Securities & Exchange Commission. The institutional investor owned 31,896 shares of the oil and gas company's stock after

selling 10,072 shares during the period. Ritholtz Wealth Management's holdings in Ecopetrol were worth \$346,000 at the end of the most recent reporting period.

A number of other institutional investors have also recently made changes to their positions in EC. Candriam Luxembourg S.C.A. purchased a new position in shares of Ecopetrol during the first quarter valued at about \$25,834,000. BlackRock Inc. grew its position in shares of Ecopetrol by 98.0% during the first quarter. BlackRock Inc. now owns 2,776,889 shares of the oil and gas company's stock valued at \$51,650,000 after purchasing an additional 1,374,075 shares in the last quarter. Arrowstreet Capital Limited Partnership purchased a new position in shares of Ecopetrol during the first quarter valued at about \$14,665,000. Itau Unibanco Holding S.A. purchased a new position in Ecopetrol in the fourth quarter worth about \$9,986,000. Finally, Fisher Asset Management LLC grew its position in Ecopetrol by 71.9% in the first quarter. Fisher Asset Management LLC now owns 1,578,099 shares of the oil and gas company's stock worth \$29,353,000 after acquiring an additional 660,298 shares in the last quarter. Hedge funds and other institutional investors own 1.44% of the company's stock.

Ecopetrol Trading Down 6.0 %

EC opened at \$8.64 on Tuesday. The firm has a market cap of \$17.76 billion, a P/E ratio of 5.88, a P/E/G ratio of 0.04 and a beta of 1.59. Ecopetrol S.A. has a 12 month low of \$8.59 and a 12 month high of \$19.81. The company has a current ratio of 1.46, a quick ratio of 1.17 and a debt-to-equity ratio of 0.94. The stock has a 50-day moving average of \$10.43 and a 200 day moving average of \$13.71.

Analyst Ratings Changes

Separately, TheStreet lowered Ecopetrol from a "b-" rating to a "c" rating in a research report on Tuesday, July 5th. One investment analyst has rated the stock with a sell rating and three have issued a hold rating to the company. Based on data from MarketBeat.com, Ecopetrol has an average rating of "Hold" and a consensus price target of \$15.60.

Ecopetrol SA operates as an integrated energy company. The company operates through four segments: Exploration and Production; Transport and Logistics; Refining, Petrochemical and Biofuels; and Electric Power Transmission and Toll Roads Concessions. It engages in the exploration and production of oil and gas; transportation of crude oil, motor fuels, fuel oil, and other refined products, including diesel, jet, and biofuels; processing and refining crude oil; distribution of natural gas and LPG; sale of refined and petrochemical products; supplying of electric power transmission services; design, development, construction, operation, and maintenance of road and energy infrastructure projects; and supplying of information technology and telecommunications services.
