Ecopetrol (NYSE:EC – Get Rating) last announced its quarterly earnings data on Wednesday, March 29th. The oil and gas company reported \$0.69 EPS for the quarter, topping analysts' consensus estimates of \$0.65 by \$0.04. The business had revenue of \$8.26 billion during the quarter, compared to the consensus estimate of \$8.31 billion.

Ecopetrol had a return on equity of 15.81% and a net margin of 19.92%. On average, equities research analysts forecast that Ecopetrol S.A. will post 2.24 EPS for the current fiscal year.

ANALYST UPGRADES AND DOWNGRADES

EC has been the topic of several recent research reports. **StockNews.com** initiated coverage on shares of **Ecopetrol** in a research note on Thursday, May 18th. They set a "hold" rating on the stock. The Goldman Sachs Group lowered their target price on shares of **Ecopetrol** from \$12.40 to \$11.00 and set a "neutral" rating on the stock in a research note on Wednesday, March 15th. Four investment analysts have rated the stock with a hold rating, According to data from MarketBeat, **Ecopetrol** has an average rating of "Hold" and a consensus target price of \$12.00.
