## SHORT INTEREST IN **ECOPETROL** S.A. (NYSE:EC) INCREASES BY 6.2%

Ecopetrol S.A. (NYSE:EC - Get Rating) was the recipient of a large growth in short interest in the month of February. As of February 28th, there was short interest totalling 4,470,000

shares, a growth of 6.2% from the February 13th total of 4,210,000 shares. Based on an average daily volume of 2,390,000 shares, the short-interest ratio is presently 1.9 days. Currently, 0.2% of the company's stock are sold short.

#### INSTITUTIONAL INFLOWS AND OUTFLOWS

A number of hedge funds have recently bought and sold shares of the stock. BlackRock Inc. increased its stake in Ecopetrol by 6.2% during the 3rd quarter. BlackRock Inc. now owns 5,145,205 shares of the oil and gas company's stock valued at \$45,948,000 after purchasing an additional 298,224 shares in the last quarter. Arrowstreet Capital Limited Partnership boosted its holdings in shares of Ecopetrol by 395.4% in the 4th quarter, Arrowstreet Capital Limited Partnership now owns 3,388,012 shares of the oil and gas company's stock valued at \$35,472,000 after acquiring an additional 2,704,109 shares during the last guarter. Marshall Wace LLP boosted its holdings in shares of Ecopetrol by 158.7% in the 4th quarter. Marshall Wace LLP now owns 3,232,841 shares of the oil and gas company's stock valued at \$33,848,000 after acquiring an additional 1,983,223 shares during the last quarter. Vanguard Group Inc. boosted its holdings in shares of Ecopetrol by 5.5% in the 3rd quarter. Vanguard Group Inc. now owns 2,984,353 shares of the oil and gas company's stock valued at \$26,650,000 after acquiring an additional 156,689 shares during the last quarter. Finally, Millennium Management LLC boosted its holdings in shares of Ecopetrol by 215.8% in the 4th quarter. Millennium Management LLC now owns 2,381,687 shares of the oil and gas company's stock valued at \$24,936,000 after acquiring an additional 1,627,411 shares during the last quarter. Institutional investors and hedge funds own 1.30% of the company's stock.

## **ECOPETROL TRADING DOWN 1.9 %**

NYSE EC opened at \$9.89 on Friday. The company has a quick ratio of 1.15, a current ratio of 1.36 and a debt-to-equity ratio of 0.78. Ecopetrol has a 52 week low of \$8.59 and a 52 week high of \$19.81. The firm has a market cap of \$20.33 billion, a PE ratio of 2.60 and a beta of 1.41. The company has a 50 day moving average price of \$11.07 and a 200 day moving average price of \$10.28.

## ECOPETROL ANNOUNCES DIVIDEND

The business also recently declared a – dividend, which will be paid on Friday, December 29th. Shareholders of record on Wednesday, December 20th will be paid a dividend of \$0.1479 per share. The ex-dividend date of this dividend is Tuesday, December 19th. This represents a yield of 20.4%. Ecopetrol's payout ratio is 38.32%.

## ANALYSTS SET NEW PRICE TARGETS

Several brokerages have recently weighed in on EC. StockNews.com began coverage on shares of Ecopetrol in a research report on Thursday. They issued a "hold" rating for the company. HSBC lowered shares of Ecopetrol from a "buy" rating to a "hold" rating and reduced their price objective for the stock from \$12.50 to \$12.00 in a research note on Friday, February 10th. The Goldman Sachs Group reduced their price objective on shares of Ecopetrol from \$12.40 to \$11.00 and set a "neutral" rating for the company in a research note on Wednesday. Finally, UBS Group lowered shares of Ecopetrol from a "buy" rating to a "neutral" rating and set a \$13.00 price objective for the company, in a research note on Thursday, February 9th. Four equities research analysts have rated the stock with a hold rating, Based on data from MarketBeat, the stock currently has an average rating of "Hold" and a consensus price target of \$12.00.
