### ECOPETROL S.A. (NYSE:EC) SHARES PURCHASED BY VANGUARD PERSONALIZED INDEXING MANAGEMENT LLC

Vanguard Personalized Indexing Management LLC boosted its position in Ecopetrol S.A. (NYSE:EC -Free Report) by 17.1% in the 1st quarter, according to the company in its most recent 13F filing with the

SEC. The fund owned 23,045 shares of the oil and gas company's stock after purchasing an additional 3,364 shares during the quarter. Vanguard Personalized Indexing Management LLC's holdings in Ecopetrol were worth \$243,000 at the end of the most recent reporting period.

Other large investors also recently added to or reduced their stakes in the company. Ridgewood Investments LLC purchased a new stake in Ecopetrol in the 1st quarter valued at \$25,000. Penserra Capital Management LLC purchased a new stake in Ecopetrol in the 1st quarter valued at \$47,000. McIlrath & Eck LLC purchased a new position in shares of Ecopetrol during the 1st quarter worth \$53,000. Quadrant Capital Group LLC grew its holdings in shares of Ecopetrol by 46.6% during the 4th quarter. Quadrant Capital Group LLC now owns 5,834 shares of the oil and gas company's stock worth \$61,000 after purchasing an additional 1,855 shares during the period. Finally, Harel Insurance Investments & Financial Services Ltd. purchased a new position in shares of Ecopetrol during the 1st quarter worth \$71,000. 1.29% of the stock is currently owned by hedge funds and other institutional investors.
